- The above standalone and Consolidated audited financial results have been reviewed by the Audit Committee and thereafter approved by the Board of Directors of the Company in their respective meetings held on May 30, 2026. The audit as required under Regulations 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 has been completed by the statutory auditors of the company.
- The standalone and Consolidated audited financial results for the quarter and year ended March 31, 2026 have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other recognized accounting practices and policies to the extent applicable.
- During the previous financial year 2023-24, Interim Order were received from the Securities and Exchange Board of India ("SEBI") alleging non-compliance of provisions pertaining to wrongful gains transactions, the Company had consulted an independent law firm, and in its replies to SEBI, the Company has denied the charges in its entirety, inter alia, on the basis that these transactions are in full compliance with the prevailing laws and regulations. Company gone for appeal to challenge SEBI Interim order.
- Pending outcome of the adjudications, the Company holds its view of the validity of the nature and effect of the transactions. Accordingly, no adjustments have been made in the financial statements of the Company. Management is in the process of ascertaining the legal position of the Company for the possible cash outflow and its consequential impact on these Standalone Financial Statements.
- Based on the nature and scale of activities carried on by the Company during the year, the provisions relating to registration under Section 45-IA of the Reserve Bank of India Act, 1934 may become applicable to the Company. The management has represented that the matter is under evaluation and appropriate steps, consultations and regulatory assessments are being undertaken in this regard. Pending completion of such process, the Company has not obtained registration under the aforesaid provisions as at March 31, 2026.
- The Company/Group has not generated any revenue from operations during the year ended March 31, 2026 and continues to primarily depend upon other income comprising interest income, dividend income, and income from investments for sustaining its operations and meeting its financial obligations. Further, the Company has incurred cash losses during the current and previous financial year and is also subject to ongoing SEBI proceedings as referred in Note 3 above. These conditions indicate the existence of material uncertainty which may cast significant doubt on the Company's ability to continue as a going concern. However, the accompanying standalone financial results have been prepared on a going concern basis considering management's assessment of future business plans, realizable value of investments and financial support available to the Company.
- The Company/Group operates in a single segment and in line with Ind AS - 108 - "Operating Segments", the operation of the Company fall under only one Business which is considered to be the only reportable business segment.
- The Figures for the quarter ended March 31, 2026 and March 31, 2025 represent the difference between the audited figures in respect of the full financial year and the unaudited published year-to-date figures upto the third quarter of the respective financial year, which were subjected to limited review.

Anthropic's valuation climbs to \$965 billion, surpassing rival OpenAI

New Delhi, May 30 (IANS) The US-based artificial intelligence giant Anthropic has raised \$65 billion in its Series H funding round, pushing its post-money valuation to \$965 billion and surpassing rival OpenAI. The funding round was led by Altimeter Capital, Dragoneer, Greenoaks and Sequoia Capital. While Capital Group, Coatue, D1 Capital Partners, GIC, ICONIQ and XN also co-led the investment, according to the company. Adoption of its AI assistant Claude has accelerated significantly across enterprises globally, with its annualised revenue run rate crossing \$47 billion earlier this month, it said in an official announcement. The company further stated that the latest capital infusion will support safety and interpretability research, expansion of computing capacity, and scaling of products and partnerships amid rising demand for AI services.

 2. The standalone and Consolidated audited financial results for the quarter and year ended March 31, 2026 have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other recognized accounting practices and policies to the extent applicable.
 3. During the previous financial year 2023-24, Interim Order were received from the Securities and Exchange Board of India ("SEBI") alleging non-compliance of provisions pertaining to wrongful gains transactions, the Company had consulted an independent law firm, and in its replies to SEBI, the Company has denied the charges in its entirety, inter alia, on the basis that these transactions are in full compliance with the prevailing laws and regulations. Company gone for appeal to challenge SEBI Interim order.
 Pending outcome of the adjudications, the Company holds its view of the validity of the nature and effect of the transactions. Accordingly, no adjustments have been made in the financial statements of the Company. Management is in the process of ascertaining the legal position of the Company for the possible cash outflow and its consequential impact on these Standalone Financial Statements.
 4. Based on the nature and scale of activities carried on by the Company during the year, the provisions relating to registration under Section 45-IA of the Reserve Bank of India Act, 1934 may become applicable to the Company. The management has represented that the matter is under evaluation and appropriate steps, consultations and regulatory assessments are being undertaken in this regard. Pending completion of such process, the Company has not obtained registration under the aforesaid provisions as at March 31, 2026.
 5. The Company/Group has not generated any revenue from operations during the year ended March 31, 2026 and continues to primarily depend upon other income comprising interest income, dividend income, and income from investments for sustaining its operations and meeting its financial obligations. Further, the Company has incurred cash losses during the current and previous financial year and is also subject to ongoing SEBI proceedings as referred in Note 3 above. These conditions indicate the existence of material uncertainty which may cast significant doubt on the Company's ability to continue as a going concern. However, the accompanying standalone financial results have been prepared on a going concern basis considering management's assessment of future business plans, realizable value of investments and financial support available to the Company.
 6. The Company/Group operates in a single segment and in line with Ind AS - 108 - "Operating Segments", the operation of the Company fall under only one Business which is considered to be the only reportable business segment.
 7. The Figures for the quarter ended March 31, 2026 and March 31, 2025 represent the difference between the audited figures in respect of the full financial year and the unaudited published year-to-date figures upto the third quarter of the respective financial year, which were subjected to limited review.
 8. The figures for the previous period has been regrouped / re-arranged to make them comparable with the current period figures.
